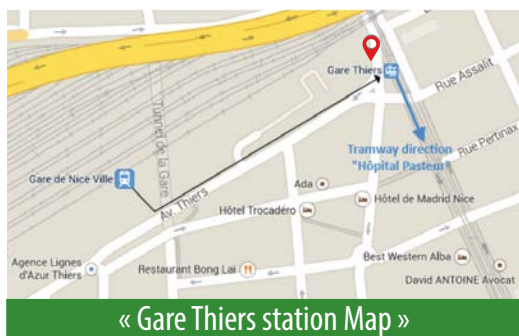

Giovanni Dosi

**'On the institutional drivers of economic evolution :
The case of de-unionization and the productivity slowdown'**

Giovanni Dosi is Professor of Economics and Director of the Institute of Economics at the Scuola Superiore Sant'Anna in Pisa; Co-Director of the task forces "Industrial Policy" and "Intellectual Property Rights", IPD - Initiative for Policy Dialogue at Columbia University; Continental European Editor of Industrial and Corporate Change. Included in "ISI Highly Cited Researchers" and Corresponding Member of the "Accademia Nazionale dei Lincei". He received in 1994 the Kapp Prize Kapp (jointly with L. Marengo, A. Bassanini and M. Valente).

A selection of his works has been published in two volumes : Innovation, Organization and Economic Dynamics. Selected Essays (2000), and Economic Organization, Industrial Dynamics and Development: Selected Essays (2012) both published by Edward Elgar.

His major research areas - where he is author and editor of several works - include Economics of Innovation and Technological Change, Industrial Economics, Evolutionary Theory, Economic Growth and Development, Organizational Studies. His last book 'Modern Evolutionary Economics :



Maria Savona

'Innovation, employment and inequalities'

Maria Savona is Professor of Innovation and Evolutionary Economics at SPRU, Science and Technology Policy Research at the University of Sussex, UK. Her main research interests are: the economics and policy of innovation in services, theory and micro-econometrics of innovation; barriers to innovation; regional distribution of innovation activities; structural change, economic growth and development. She has published widely in these areas on international peer-reviewed journals (Journal of Economic Geography, Research Policy, Cambridge Journal of Economics, Journal of Evolutionary Economics, Journal of Economic Surveys, Structural Change and Economic Dynamics, The Service Industries Journal). She is Guest Editor of a Research Policy Special Issue on "Technical Change, Innovation and History: Perspectives in Honour of Nick von Tunzelmann". She is council member of RESER (European Association for Research on Services) since 2000 and REDLAS (The Latin America and Caribbean Network on Service Research). She serves as academic evaluator for the European Commission and various European and international research councils. She is a peer reviewer for over thirty academic journals, Advisory Editor for Research Policy and Journal of Evolutionary Economics and member of the Editorial Board of the Eurasian Business Review and *Economia Politica*.

Frank Ackerman

Frank Ackerman (PhD in Economics at Harvard) is a principal economist at Synapse, Cambridge (USA), where is now leading a World Bank project to improve the reporting and forecasting of renewable energy use in Morocco.

Professor Ackerman is an environmental economist with expertise in the economics of climate change and energy, cost-benefit analysis and regulations, the economic and environmental impacts of global trade liberalization, and economic theory and methods. His critical view of narrow cost-benefit analyses of environmental protection and social cost of carbon has contributed to deepen the debate among academics and practitioners. He has directed studies for state agencies, international organizations and leading environmental NGOs, including Greenpeace. His most recent books include *Climate Change and Global Equity* (2014), and *Worst Case Economics: Extreme Events in Climate and Finance* (2017). He will be part of the Plenary session Friday.



Daniele Archibugi

Daniele Archibugi is a Research Director at the Italian National Research Council (CNR) in Rome, affiliated at the Institute on Population and Social Policy (IRPPS), and Professor of Innovation, Governance and Public Policy at the University of London, Birkbeck College, Department of Management. He works on the economics and policy of technological change and on the political theory of international relations. He is an adviser to the European Union, the OECD, several UN agencies and various national governments.

He has led many research projects for the European Commission and other international organizations. He has chaired the European Commission's Expert Group on "A Wide Opening of the European Research Area to the World" and he has been a member of the Expert Group of the European Commission "Global Europe 2030/2050". His latest book is *Crime and Global Justice, The Dynamics of International Punishment* with Alice Pease (Polity, 2018). He will be part of the session in RA L.



**Uwe
Cantner**

Uwe Cantner is full Professor of Economics at the FSU Jena, affiliated to the University of Southern Denmark/Odense and is Vice President for Young Researchers and Diversity Management at FSU Jena. Professor Cantner is also member of the Expertenkommission Forschung und Innovation at the Federal German Government and the former President of the International Joseph A. Schumpeter Society.

He is editor in chief of the Journal of Evolutionary Economics. AF Hendarman (2018). Uwe Cantner will give a key note at the Plenary Session "Evolutionary foundations" Saturday.

His has many publications on Economics of Innovation, Evolutionary Economics, Industrial Economics, Productivity: Theory and Measurement, Entrepreneurship.

Among his latest publications "Foundations of Economic Change: An Extended Schumpeterian Approach" (2017), "Soft skills, hard skills, and individual innovativeness" with AF Hendarman (2018).

**Kurt
Dopfer**

Kurt Dopfer is an Austrian-born Swiss economist, since 1980 Professor at the Department of Economics of University of St. Gallen, Switzerland, chair of international economics and development theory, Co-director of Institute of Economics, member University Senate, Emeritus, and researcher of Swiss National Science Foundation.

Kurt Dopfer published several books and numerous articles in twelve languages, has been a member of the editorial board of several journals, such as the Journal of Evolutionary Economics. Kurt Dopfer is best known for several contributions in evolutionary economics, such as the axiomatization of evolutionary economic approach (Dopfer, 2001, 2005). Kurt Dopfer will be part of the book launching session Friday for presenting his contribution to the book Modern Evolutionary Economics, CUP 2018.



**Wilfred
Dolfsma**

Wilfred Dolfsma is professor of Business Management & Organization (BMO) at Wageningen University & Research. Here he also is chair holder of the BMO group. Earlier, at Loughborough University London, he was professor of Innovation & Entrepreneurship, director of the Institute for Innovation & Entrepreneurship, and Associate Dean (Teaching).

Wilfred's academic expertise is about how individuals and firms collaborate to be more entrepreneurial and innovative so that they may be better positioned to successfully contribute to society. In 2016, Professor Dolfsma has been awarded with the Myrdal Prize his 2004 book, *Institutional Economics and the Formation of Preferences: The Advent of Pop Music*.



**Agnès
Labrousse**

Agnès Labrousse is assistant professor in Economics University of Picardy - Jules Verne, Amiens Lecturer at EHESS, Researcher at CRIISEA (Amiens) and Research Associate at CEMI-EHESS (Paris).

Her research topic is on theories of institutions and organizations, German-language economic thought (19-20th), theory and epistemology of development economics, pharmaceutical industry (organization of work and production, political economy of norms) and East German economy. She has been recently awarded with the Kapp Prize 2016 and the Ostrom Prize in 2017 for the paper "Not by Technique alone: A Methodological Comparison of Development Analysis with Esther Duflou and Elinor Ostrom".

**Keun
Lee**

Keun Lee is a Professor of Economics at the Seoul National University, and the winner of the 2014 Schumpeter Prize for his monograph on Schumpeterian Analysis of Economic Catch-up (2013 Cambridge Univ. Press).

Keun Lee is the President of the International Schumpeter Society (2018), a member of the Committee for Development Policy of UN, an editor of Research Policy, and a council member of the World Economic Forum. He obtained Ph.D. in economics from the University of California, Berkeley. One of his most cited articles is a paper on Korea's Technological Catch-up published in Research Policy, with 1,060 citations (Google Scholar).

His H-index is now 37, with 88 papers with more than 10 citations.

**Philip
O'Hara**

Phillip Anthony O'Hara is a professor of global political economy and governance at the Curtin University of Technology and the director of the university's Global Political Economy Research Unit. An associate editor of the Review of Social Economy, O'Hara specializes in political economy, the history of economic thought, and international economics.

Dr Phillip O'Hara is past-President of the Association for Evolutionary Economics (AFEE) (2013-14) and director of the Global Political Economy Research Unit (GPERU) and served as the editor for Encyclopedia of Political Economy.

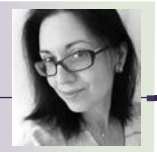

**Pavel
Pelikan**

Pavel Pelikan is a professor of institutional economics at the University of Economics in Prague. He was previously a researcher at the Institute for Industrial Economics in Stockholm, a permanent visiting professor at l'Université de Paris 1 – Sorbonne, an associate professor at the University of Toronto, a visiting scholar at the University of California in Berkeley and the Carnegie-Mellon University in Pittsburgh, a researcher at the Institute for National Economic Planning in Prague, and an assistant at the Institute for Mathematical Machines in Prague.

His work is interconnecting the fields of institutional economics, evolutionary and developmental economics, and cognitive sciences in search of a reliable and sufficiently comprehensive analysis of economic policies. His main publications 'Economics for a creative world : some agreements and some criticism', *Journal of Institutional Economics* (2015), "Bringing institutions into evolutionary economics: another view with links to changes in physical and social technologies" (2003) and "Language as a limiting factor for centralization" in *The American Economic Review* (1969). Pavel Pelikan will give a key note at the Plenary Session "Evolutionary foundations" Saturday and will chair some SS.



**Annie
Tubadji**

Annie Tubadji is a Lecturer in Economics at UW. She is a cultural economist and teaches microeconomics and economics of happiness.

Annie's main areas of expertise are New Cultural Economics (NCE) and Regional Economics. She focuses on the cultural bias in economic choice as a function of the interaction between the micro and macro levels.

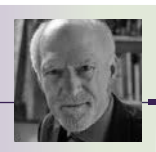

Smita Srinivas has been awarded with Myrdal Prize winner in 2015 for her book on "Market Menagerie: Health and Development in Late Industrial States" (Stanford University Press, 2012). **Andrew
Tylecote**

Andrew Tylecote is an institutional economist, Emeritus Professor Management of Technological Change – University of Sheffield from 2011. His focus has been on macroeconomic issues, on inflation, now mostly on technological progress and economic growth. His contribution to them comes from his attention to the institutional and micro-economic foundations on which a realistic macro-economic should be built. That has led Andrew Tylecote to a parallel focus on the firm, its finance and governance and how that affects its technological development.



Ulrich Witt

Ulrich Witt is a German economist and former Director of the Evolutionary Economics Group at the Max Planck Institute of Economics in Jena (Germany). His areas of research include evolutionary economics, long-term trends in economic development, as well as transformations that economic institutions, production, and consumption activities undergo over time. He was awarded the K. William Kapp Prize from in 1992 and received an honorary doctorate from the University Witten-Herdecke in 2003.

Central to his work is the idea of a naturalistic approach to evolutionary economics. His research connects insights from different disciplines such as biology and psychology and economics with the aim to enrich economic thinking. He applied this approach both to consumer theory and the theory of the firm. Ulrich Witt is editor in-chief of the Journal of Bioeconomics.

He published in 2008 the book "Recent Developments In Evolutionary Economics", (Aldershot: Edward Elgar) in which he highlights a variety of pressing economic problems, explaining causes and arriving at innovative remedies, on developments in: innovations, knowledge transfer, industrial dynamics, evolutionary game theory, and ecological economics. Ulrich Witt will be part of the book launching session Friday for presenting his book "Understanding Economic Change - Advances in Evolutionary Economics" CUP 2018 (with A. Chai) and will present his work within the conference the same day.



Stefano Battiston

Stefano Battiston is SNF Professor at the Department of Banking and Finance of the University of Zurich. His work applies the complex networks approach both to the empirical analysis of large economic networks and the modelling of their dynamics. Since several years, his main interests have been financial contagion, default cascades, and propagation of financial distress, where he combines the insights from the statistical mechanics of networks with the analysis of economic incentives.

He has been involved in many international projects, including FOC (Forecasting Financial Crises) the first European project aimed at anticipating structural instabilities in the global financial networks. He is now the coordinator of the FET project SIMPOL that investigates policy modeling in finance and climate finance.



Massimo Tavoni

Massimo Tavoni is associate professor at the Dept. of Management and Economics at Politecnico di Milano (IT) and director of the recently launched European Institute on Economics and the Environment (EIEE), a new transatlantic research institute on climate change and natural resource economics that includes CMCC Foundation – Euro-Mediterranean Center on Climate Change and Resources for the Future (RFF). In 2015, Massimo was a Fellow at the Center for Advanced Studies in the Behavioural Sciences at Stanford University, and from 2008 to 2010 a post doctoral research associate at Princeton University.

He holds a Laurea cum Laude in Engineering from the University of Bologna, an MSc in Mathematical Economics from the London School of Economics, and a PhD in Political Economics from the Catholic University of Milan. Massimo's research focuses on energy and climate change economics. In particular, he has extensively worked on modeling and evaluation of international climate mitigation policies using Integrated Assessment Models. He was also a lead author for the 5th IPCC report. Massimo has published extensively in the peer reviewed literature, including work that was featured in "Time" magazine's list of "The 50 Best Inventions of 2009", and he is deputy editor for the journal Climatic Change. He will be part of the plenary session Friday " Research advances on climate-finance".

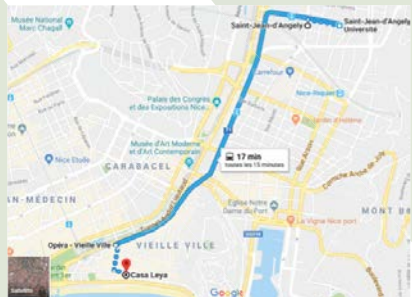
