The EAEPE Summer School is open to **PhD students** and **early-career researchers** working in particular in the field of institutional and evolutionary analysis, with a special focus this year on structural change, aggregate demand, institutions and economic development. Teachers will address these important topics from **different perspectives** and **approaches**. In the spirit of **pluralism** characteristic of the EAEPE, many **Research Areas** are relevant: human development, environment-economy interactions, methodology of economics, institutional history, comparative economics, transition economics, institutional change, innovation and technology, and labour economics. More generally, contributions from all fields using institutional, multidisciplinary approaches are welcome. Lectures by **internationally-renowned scholars** will be given in the morning, while afternoons will be devoted to presentations by **advanced PhD students** and **early-career researchers**, who will thus benefit from comments and suggestions from experts in the field.
